1. Call to order at 4:31 PM by Chairman Tim Candahl.
2. Pledge of Allegiance.
3. Motion by Wichelt/Candahl to approve the minutes of the March 24, 2014 Town Board Meeting as presented. Motion carried.
4. Motion by Wichelt/Candahl to approve bills as line items. Totals incomplete on report. Motion carried. Copy attached
5. Allen Lueck, N912 Justin Rd appeared to ask the Board what road work was planned for Justin Rd. A news article indicated there would be work done this year. Administrator said there were no plans and he was not aware of the news article. The information did not come from the Town of Shelby.
6. Board reviewed the latest draft of the proposed sign ordinance and made one minor adjustment, changing the term "Digital Message Unit" to "Electronic Message Unit". Clerk directed to post the draft ordinance on the web site along with a notice that the Town Board would be acting on the ordinance at their regularly scheduled town board meeting on Monday, May 12, 2014. Written comments will be accepted through May 5th. Oral comments at the meeting will be limited to 3 minutes and Town of Shelby residents only.
7. Motion by Wichelt/Ehler to approve the new applications to keep a 3rd dog for: Rainey Jo Nickley, N889 Skemp Road; Heidi Cary, 2936 Ebner Coulee Road; and Daryl Brye, N189 Cedar Hills Lane. Motion carried unanimously.
8. Motion by Ehler/Wichelt to approve the appointment of Jeff Schnier to Fire Department Captain. Motion carried unanimously.
9. Administrator went through the background of the drainage problems @ Bloomer Mill & Lauterbach Roads and the possible solutions. Motion by Wichelt/Ehler to have the Administrator move forward on a plan to have the town take care of the problems and assess back the cost to the property owners. Motion carried unanimously.

10. Fire Chief Mike Kemp went through the April Fire Department Report. He also told the Board the Shelby Fire Dept volunteers would be helping with a marathon on May 3rd. The City of La Crosse will be closing Bliss Road from 4:30 to 6:30 PM.
11. Board reviewed the March Police Department Report. Copy attached.

13. Board reviewed the Treasurer's Report. Clerk/Treasurer discussed town board recertification by attending Board of Review Training on May 8, 2014 in Tomah.
14. Supervisor Joyce Wichelt reported receiving a phone call from a resident of Knobloch Road regarding the roughness of the road access from Hwy 33 due to road construction. Board will pass on her concern to the WI Dept of Transportation.
15. Board discussed issues for Town Chairman Candahl to discuss with La Crosse Mayor Kabat including: baseball parking lot, resident notification of Bliss Road closure for the May 3rd marathon, hiking trails through the bluffs, and the sign ordinance.
