

TOWN OF SHELBY BOARD MEETING MINUTES

TOWN OFFICIALS EXCUSED:

1. Call to order at 4:30 PM by Chairman Tim Candahl.
2. Pledge of Allegiance
3. Motion by Wichelt/Candahl to approve the minutes of the April 12, 2011 Board Meeting as corrected. Motion carried. Ehler was not present.
4. Motion by Wichelt/Candahl to approve payment of the bills in the amount of \$13,562.60. Motion carried. Copy attached. Ehler was not present.
5. Motion by Wichelt/Candahl to recommend approval of the application of Rodney Kadrmas, N1189 Continental Lane, to construct an outbuilding that lies within the setback from the road and exceeds the size limit for that that lot. Motion carried. Ehler was not present.
6. Motion by Ehler/Wichelt to recommend approval of the application of Robert Billings, 4205 Bank Dr, for a variance to build a garage the lies with the setback from Boschert Street. Motion carried unanimously.
7. Administrator went through the rewrite of the La Crosse County Zoning Ordinance and the former town board's position on proposed changes. Copy attached. Board will have an opportunity to comment at public hearings.
8. Administrator discussed and answered questions re WI DOT reconstruction of State Road 33 from 32nd Street to Deerview Drive. Summary attached. The DOT will hold a project information meeting this summer.
9. Motion by Wichelt/Ehler to appoint Beverly Kratt to the list of Election Inspectors for 2010-2012. Motion carried unanimously.
10. Administrator's Report. Copy attached.
11. Board moved the next Town Board Meeting from Monday, May 9th to Tuesday, May 10th, 2011.
12. Board asked that an overview of 2010 health insurance possibilities be an agenda item for the next meeting.

13. Board agreed to tour the Town on Monday, May 16, 2011. Tour will start at the town hall @ 4:30 PM.
14. Clerk discussed 2011 Property Assessment, Open Book and Board of Review. She has ordered a training disk from UW Extension for the Board to prepare them.
15. Chairman reported a suggestion to consider a Spring Clean Up Day in Shelby, his attendance at the Chamber of Commerce candidate forum, and a meeting with La Crosse Mayor Matt Harter re Bliss Road. He said he will also be meeting with the La Crosse Co Administrator Steve O'Malley to discuss Bliss Road and will report back to the town board.
16. Citizen Comments: Alan Schultz, 3305 Ebner Coulee Road, discussed problem with invasive species, overpopulation of deer, Bliss Road closure and maintenance of and excessive speeds on Ebner Coulee Road. Administrator told him the town would increase police presence to curb speeding.
17. Supervisor Wichelt asked the board to consider holding one town board meeting per month instead of two.
18. Agenda items for the next board meeting include reconstruction of State Road 33 and land purchase on Old Vineyard Road.
