 - b. Lundsten motion to award Arbor Hills Well Project to low bidder Traut Companies, second by Knutson. Motion carried unanimously.
 - c. (4:45 after call with Ed Maxwell and Meter/ Sewer Rate Increase Discussion) Discussion on 2020 Budget. Board will take time to look over budget and accept next time.
